

## Visiting Groups Risk Assessment And Management

### Risks Involved in a Visit to the Waikite Valley Thermal Pools

Given that this is a swimming based activity we require a ratio of 4:1 of children to teachers or parents.

Supervision at all times is the responsibility of the group organizer/leader.

The group organizer /leader must first see management before the children enter the pool premises. You will be given instructions for the group. School groups will generally be restricted to the splash pool.

<b>Risk identification</b>	<ol style="list-style-type: none"> <li>1. Scrapes and bruises/fractures</li> <li>2. Burns and scalds</li> <li>3. Drowning</li> </ol>	<ol style="list-style-type: none"> <li>1. Concrete areas around pools and changing rooms.</li> <li>2. Walkway, hot pipes and hot water.</li> <li>3. Swimming pools, private pools and Te Manaroa Spring</li> </ol>	<ol style="list-style-type: none"> <li>1. Weather, wet concrete areas are slippery.</li> <li>2. Geothermal water on surfaces around the pool and in changing rooms are slippery</li> </ol>
<b>Risk Management</b>	<ol style="list-style-type: none"> <li>1. Outline procedures for moving around the complex, walking NOT RUNNING</li> <li>2. All signage to be adhered to at all times. Restricted areas to be kept away from.</li> <li>3. Access to Te Manaroa Spring only with active adult supervision.</li> <li>4. Active supervision with ratios as per specified at all times while in the complex.</li> </ol>	<ol style="list-style-type: none"> <li>1. Children must at all times walk, not run</li> <li>2. Children at all times must follow the instructions as set out by the group supervisor or be removed from the complex.</li> <li>3. Children must stay within the designated pool areas. Children must not enter the walkway without the active supervision by a designated supervisor.</li> </ol>	<ol style="list-style-type: none"> <li>1. Adhere to all signage re wet slippery surfaces.</li> <li>2. Children to use the correct entry and exit points around the pool to minimize geothermal wet spots.</li> </ol>
<b>Coping with Emergencies</b>	<ol style="list-style-type: none"> <li>1. Assess the situation and treat as needed</li> </ol>	<ol style="list-style-type: none"> <li>1. All senior staff hold current first aid certificates and are trained in CPR.</li> <li>2. First aid kit is available.</li> <li>3. Ambulance if needed</li> </ol>	<ol style="list-style-type: none"> <li>1. Know boundaries.</li> <li>2. Adhere to all signage.</li> <li>3. Use safety mat areas.</li> </ol>
